TEMPORARY PROHIBITION OF PEDESTRIANS ORDER 2024

NOTICE is hereby given that the County Borough Council of Torfaen in exercise of their powers under the Road Traffic Regulation Act 1984 (as Amended) intend not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians and cyclists from proceeding along Public Footpath No. 162 running from Llantarnam Sports Pitch up the side of Llantarnam CP School to James Prosser Way housing estate for approximately 140 metres.

An alternative route has been identified and is shown on the Order Plan by a dashed black line marked C-D.

The prohibition is necessary because of the likelihood of danger to the public.

The proposed Order will come into operation on 7 February 2024 and will continue in force for a period of 6 months or until the works have been completed, whichever is the sooner.

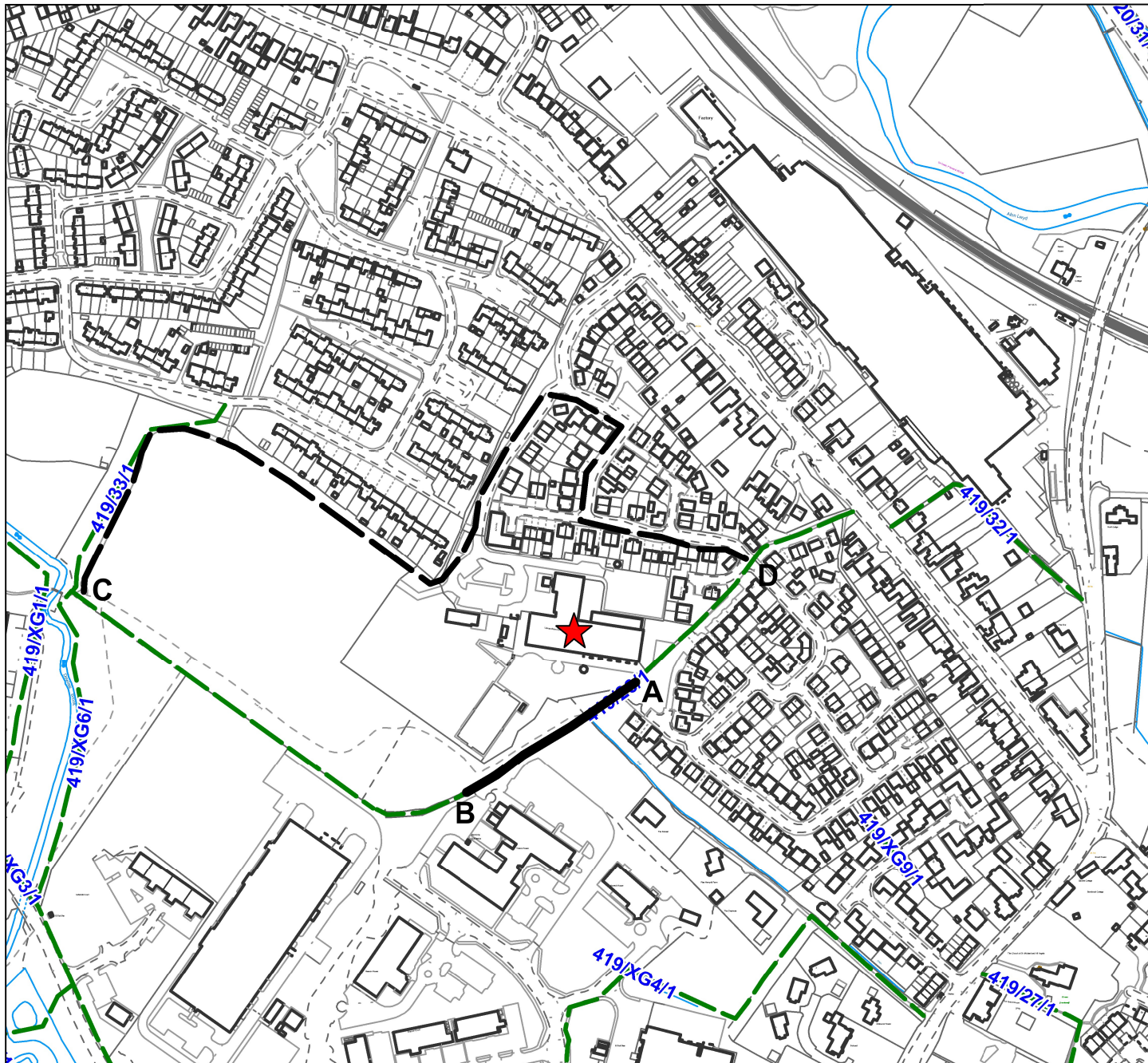
