TEMPORARY PROHIBITION OF PEDESTRIANS ORDER 2022

NOTICE is hereby given that the County Borough Council of Torfaen in exercise of their powers under the Road Traffic Regulation Act 1984 (as Amended) intend not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians and cyclists from proceeding along Public Footpath No. 48 from its junction with Coed-y-Canddo Road. The footpath then runs in a generally north-easterly direction for approximately 274 metres to its junction with Public Footpaths No's 45 and 45A Panteg/Pontypool and is shown by a bold black line from A-B on the Order Map.

No alternative routes are available for use by the public.

The prohibition is necessary because of the likelihood of danger to the public.

The proposed Order will come into operation on 28 September 2022 and will continue in force for a period of 6 months or until the works have been completed, whichever is the sooner.

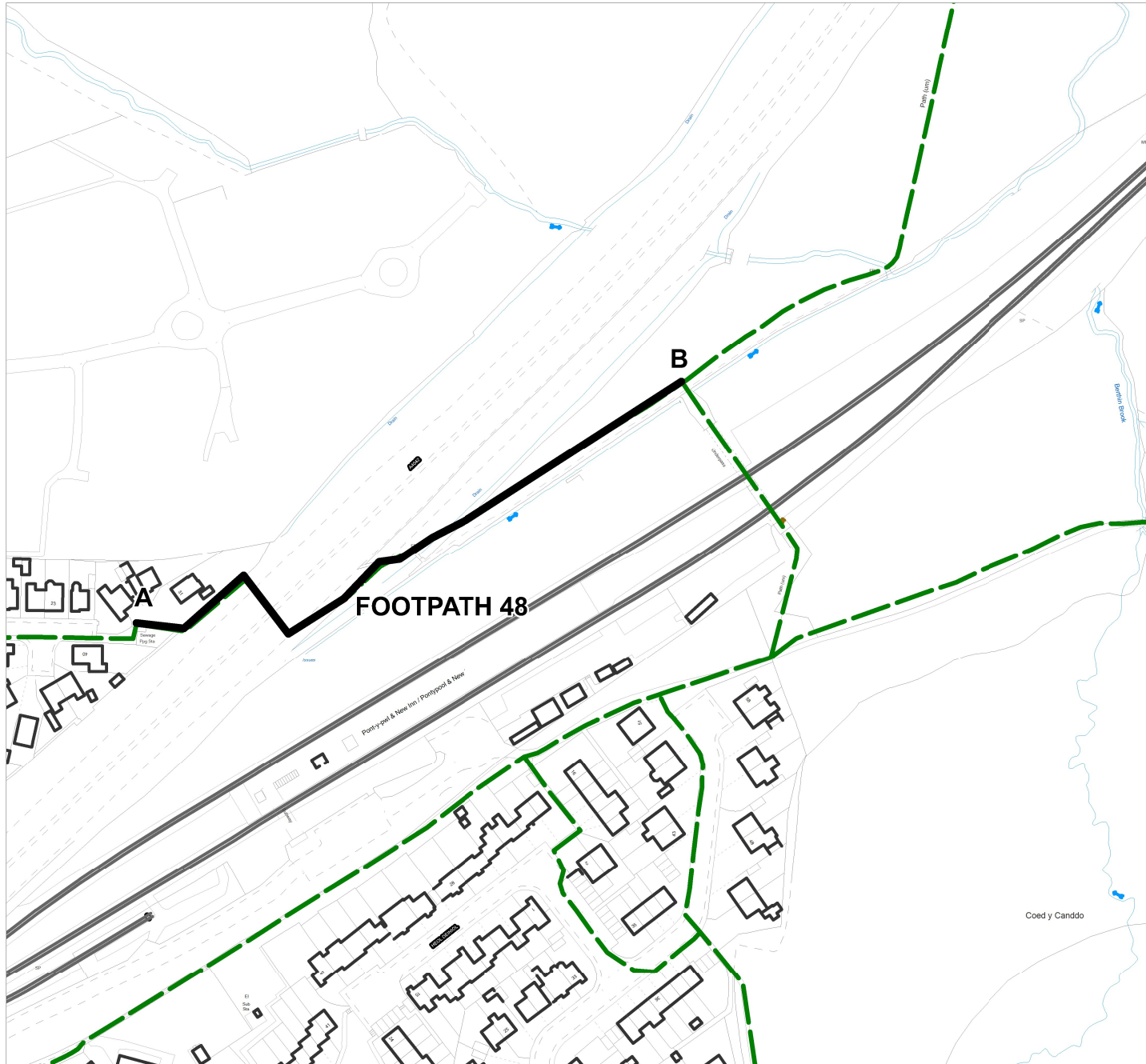

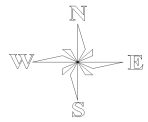
