The Torfaen Housing Intervention Panel (THIP) is a monthly multi-agency meeting designed to facilitate the sharing of information to address issues faced by individuals (and their families) that place them at risk of losing their home, or of harm due to the accommodation that they are presently residing in. In addition, the THIP will work with individuals and families where there are significant anti-social behaviour issues that require a multi-agency approach to resolve them.

Torfaen Housing Service processes information in relation to you and your family in order to deal with requests for housing advice, assistance and support.



# 1) Who provides your data to the Council?

Some of the personal information we process is provided to us directly by you e.g. by completing an application form for housing or presenting to the Council as homeless.

## AND

We receive some information indirectly from others who know you, e.g. other Local Authority departments, Housing Associations and support providers. The Council puts measures in place to protect the privacy of individuals throughout this process.

### 2) How does the Council collect this information:

The Council collects your information in a number of ways:

- via online applications forms
- over the telephone
- shared with us by other agencies.

## 3) <u>What information does the Council collect about you?</u>

We collect personal information such as:

- Name
- Address
- Date of birth
- Gender
- Disability status
- Telephone number
- Email Address
- Current Housing Circumstances
- Household Details
- Work / Employment Status
- Benefits
- UK Residency status
- National Insurance Number
- Financial Details
- Additional Support Needs
- Criminal Convictions / Offences



### 4) Why does the Council process your personal data?

Under Article 6 of the UK General Data Protection Regulation (GDPR), the lawful basis we rely on for processing this information is:

(e) We need it to perform a public task.

#### 5) <u>Special categories of personal data:</u>

We collect the following special category data:

- personal data revealing racial or ethnic origin
- personal data revealing religious or philosophical beliefs
- data concerning health
- data concerning a person's sexual orientation

We collect this under Article 9 of the UK GDPR.

Where we collect criminal data, this is processed within the Council under Article 10 of the UK GDPR.

### 6) Who has access to your data?

Your data is shared internally only with the appropriate staff where it is necessary for the performance of their roles.

To enable the Council to meet its legal obligations as outlined above we may share your information externally with the partner organisations listed at the top of this privacy notice as members of the Torfaen Housing Intervention Panel. We will only share your information with another department or agency where relevant to making further enquiries to support you with your housing issue or to meet a legal obligation.

Your data may also be shared with external organisations not listed as a partner above where it is necessary to include them in the meetings to provide best outcomes. These may include, but not be limited to

- The Police
- Probation Services
- National Health Service
- Department for Work & Pensions
- Gwent Drug & Alcohol Service

Apart from where previously stated, we do not pass your details to third parties unless we are lawfully required do so.

## 7) How does the Council keep your data secure?

The Council has internal policies in place to ensure the data it processes is not lost, accidentally destroyed, misused or disclosed. Access to this data is restricted in accordance with the Council's internal policies and in compliance with the UK GDPR.

Data will be stored securely in:

- the Council's secure network server
- a secure IT database used for delivering most of our housing services which has ISO 27001 certification.

Where the Council engages third parties to process personal data on its behalf, they do so on the basis of written instructions. These third parties are also under a duty of confidentiality and are obliged to implement appropriate measures to ensure the security of data.

## 8) <u>How long does the Council keep your data?</u>

The Council will hold your personal data only for the period that is necessary and will follow organisational and Local Authority standards in this area. At the end of the retention period the Council will securely destroy or dispose of the data in line with retention schedules.

• The agreed retention period for Housing records is 7 years.

## 9) <u>Are we making automated decisions/profiling with your data?</u> No

## Your rights

You have a number of Rights you can exercise:

- Access to obtain a copy of your data on request
- Rectification to require the Council to change incorrect or incomplete data
- Object, Restrict or Delete under certain circumstances you can require the Council to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing

- Data portability to receive and/or transmit data provided to the Council to other organisations (this applies in limited circumstances)
- Withdraw your consent at any time (where consent has been given)
- To know the consequences of failing to provide data to the Council
- To know the existence of any Automated Decision-making, including profiling, and the consequences of this for you.
- To lodge a complaint with a supervisory authority (Information Commissioners Office)
