  - 6. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Civic Centre, Pontypool NP4 6YB by 5 p.m. on **Wednesday 5 February 2025**.
  - 7. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Civic Centre, Pontypool, Torfaen, NP4 6YB by 5 p.m. on Thursday 13 February 2025. The physical incapacity must have occurred after 5pm on Wednesday 5 February 2025. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday 5 February 2025.
