**NOTICE IS HEREBY GIVEN** that a casual vacancy exists for a community councillor for the above Community Council and ward.

The casual vacancy will be filled by election if, within 14 working days of the date of this notice (i.e. by 5pm on 18 December 2024), ten electors from within the relevant community ward submit a written request for a by-election to the Proper Officer of Torfaen County Borough Council, Stephen Vickers.

The requests from the ten electors may be submitted together, separately, or a combination of the two.

Once the requests have been received, polling day for the by-election will be set by the Returning Officer within 60 working days of the date of receipt of the requests.

If the required ten requests for a by-election are not received in the 14 working days after this notice of vacancy has been published, the community council will fill the vacancy by co-option. This co-option will take place as soon as is practicable after the end of the 14 working day period.
