**NOTICE OF VACANCY**

**NOTICE IS HEREBY GIVEN** that a casual vacancy exists for a councillor for the above council and ward.

This casual vacancy will be filled by election when two local government electors from within the local authority area submit a written request for a by-election to the Returning Officer, Stephen Vickers.

The requests do not have to arrive at the same time and can be in any form (for example, letter or email) and do not necessarily have to be signed. They can be a request by two electors, or two separate requests from individual electors in the local authority area.

Once two requests have been received, polling day for the by-election will be set by the Returning Officer within 35 working days of the date of receipt of the requests.

There is no time limit for receiving the requests but, if the required number is not received, the seat will remain vacant.
