CONDITIONS OF LICENCES

The Conditions of Licences granted by Torfaen County Borough Council are based on recommendations made by the Home Office and on standard conditions for Petroleum Licensing as produced by the Local Authorities Coordinating Body on Food and Trading Standards.

NOTES

1. Whenever any accident which occasions loss of life or personal injury occurs by explosion or by fire in or about or in connection with the licensed premises shall, if the explosion or fire involved petroleum spirit, forthwith send or cause to be sent to the Secretary of State (Home Office), Whitehall, London SW1, notice of the accident, and of loss of life or personal injury. A notice of any accident of which notice is so sent need not be sent to any Inspector of Factories.
2. Attention is directed to the requirements of Section 5 of the Petroleum (Consolidation) Act 1928 and to the Petroleum (Mixtures) Order, 1929.
3. Conveyance of Petroleum Spirit by road. Attention is directed to the regulations made by the Home Secretary.
4. A Licence may be transferred to some other person by endorsement by Torfaen County Borough Council.
