THERFYNAU CYFLYMDER 2019

(DIWYGIAD RHIF 13)

HYSBYSIR trwy hyn bod Cyngor Bwrdeistref Sirol Torfaen, yn unol â'r Rheoliadau Gorchymynion Traffig Awdurdodau Lleol (Gweithdrefn) (Cymru a Lloegr) 1996 a'r Ddeddf Rheoleiddio Traffig Ffyrdd 1984 (cyfeirir ati ar ôl hyn fel "y Ddeddf"), fel y'u diwygiwyd a Rhan IV Atodlen 9 y Ddeddf, a phob pŵer galluogi arall, ac ar ôl ymgynghoriad â Phrif Swyddog yr Heddlu, yn bwriadu gwneud y Gorchymyn uchod a diwygio'r cyfyngiadau ar y ffyrdd canlynol:-

- Gosod terfyn cyflymder o 40mya ar y rhannau o'r ffordd a bennir yn Atodlen 1 i'r hysbysiad hwn.
- Dirymu'r terfyn cyflymder o 40mya ar y rhan o'r ffordd a bennir yn Atodlen 2 i'r hysbysiad hwn.

ATODLEN 1

- Usk Road (o'i chyffordd â chylchfan Horse & Jockey am bellter o 457m i gyfeiriad de orllewin)
- B4246 Varteg Road (o bwynt 123m i'r gogledd o'i chyffordd â Salisbury Terrace am bellter o 604m i gyfeiriad y gogledd)
- B4246 Varteg Road (o bwynt 511m i'r de-ddwyrain o'i chyffordd â ger-yr-efail am bellter o 648m i gyfeiriad y gogledd orllewin)
- Ger-yr-efail (o'i chyffordd â B4246 Varteg Road am bellter o 669m i gyfeiriad y gogledd orllewin)
- B4246 Abergavenny Road (o bwynt 62m i'r gogledd o'i chyffordd â Rifle Street am bellter o 496m i gyfeiriad y gogledd)

ATODLEN 2

- Newport Road (o bwynt 44m i'r de-orllewin o'i chyffordd â The Maltings i'w chyffordd â Chylchfan Crown)
- Llantarnam Park Way (o'i chyffordd â chylchfan Newport Road am bellter o 68m i gyfeiriad y gorllewin)
- Llantarnam Road (o'i chyffordd â Court Road i'w chyffordd â Llanfrechfa Way)

9. St Davids Road (o'i chyffordd â chylchfan Llanfrechfa Way i'w chyffordd â Station Road (yn cynnwys cylchfan Tudor Road a chylchfan Morrisons)
10. Avondale Road (part of) (o'i chyffordd â Station Road i'w chyffordd â Pontrhydyrun Road)

Effaith y Gorchymyn arfaethedig fydd diwygio Gorchymyn Cyfunol Cyngor Bwrdeistref Sirol Torfaen (Heolydd Amrywiol) (Rheoli Traffig a Therfynau Cyflymder) 2019, yn y modd y bydd yr heolydd ac Atodlenni'r Map a bennir yn Atodlen Gyntaf y Gorchymyn yn cael eu diwygio a bydd yr heolydd ac Atodlen y Map a bennir yn yr Ail Atodlen yn cael eu gweithredu.

TORFAEN COUNTY BOROUGH COUNCIL
(VARIOUS ROADS) (TRAFFIC REGULATION AND SPEED LIMIT)
CONSOLIDATION ORDER 2019
(AMENDMENT NO. 13)

NOTICE is hereby given that Torfaen County Borough Council in accordance with the Local Authorities Traffic Order (Procedure) (England & Wales) Regulations 1996 and the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), as amended, and Part IV of Schedule 9 to the Act and of all other enabling powers and, after consultation with the Chief Officer of Police, propose to make the above Order and to amend the restrictions on the following roads:-

- a. To impose a speed limit of 40mph on the lengths of road specified in Schedule 1 to this notice.
- b. To revoke the 40mph speed limit on the length of road specified in Schedule 2 to this notice.

SCHEDULE 1

1. Usk Road (from its junction with Horse & Jockey Roundabout for a distance of 457m in a south westerly direction)
2. B4246 Varteg Road (from a point 123m north of its junction with Salisbury Terrace for a distance of 604m in a northerly direction)
3. B4246 Varteg Road (from a point 511m south east of its junction with Forgeside for a distance of 648m in a north westerly direction)
4. Forgeside (from its junction with B4246 Varteg Road for a distance of 669m in a north westerly direction)
5. B4246 Abergavenny Road (from a point 62m north of its junction with Rifle Street for a distance of 496m in a northerly direction)

SCHEDULE 2

6. Newport Road (from a point 44m south west of its junction with The Maltings to its junction with Crown Roundabout)
7. Llantarnam Park Way (from its junction with Newport Road Roundabout for a distance of 68m in a westerly direction)
8. Llantarnam Road (from its junction with Court Road to its junction with Llanfrechfa Way)
9. St Davids Road (from its junction with Llanfrechfa Way roundabout to its junction with Station Road (including Tudor Road roundabout and Morrisons roundabout))
10. Avondale Road (part of) (from its junction with Station Road to its junction with Pontrhydyrun Road)

The proposed Order shall have the effect of amending the Torfaen County Borough Council (Various Roads) (Traffic Regulation and Speed Limit) Consolidation Order 2019, in that the Map Schedules specified in the First Schedule to the Order shall be amended and the Map Schedule specified in the Second Schedule to the Order shall be implemented.
